**NOTICE OF RACE**  
**MAX AND EDNA BERMAN MEMORIAL TROPHY RACE**  
**SATURDAY 16<sup>th</sup> APRIL 2022**  
Issued April 2022

**1. ORGANISING AUTHORITY**

- 1.1. The Organising Authority is Port Stephens Yacht Club.
- 1.2. The event is to celebrate the contribution of founding members Max and Edna Berman and conducted in the intended format on Saturday 16<sup>th</sup> April.

**2. RULES**

- 2.1. Racing shall be conducted under the 2021-2024 Racing Rules of Sailing, and the prescriptions and safety regulations of Australian Sailing as modified by the PSYC Sailing Instructions. This Notice of Race or the Sailing Instructions may be altered, varied, deleted or added to by displaying a written notice in the form of an addendum or amendment on the PSYC Notice Board prior to 1100 hours on any race day, or communicated by the Race Officer on VHS CH77 before the Warning Signal (AYF Rule 90.2c).
- 2.2. If there is a conflict between this Notice of Race and the Sailing Instructions, then the Notice of Race shall take precedence.
- 2.3. Both series will be conducted within the constraints dictated by the NSW Government and NSW Police Maritime Command.
- 2.4. The race is a single division standalone no extras (non-spinnaker) event.

**3. ELIGIBILITY AND ENTRY**

- 3.1. PSYC Season 2021 - 2022 is open to keel boat, trailer sailer and multihull classes of yacht that are on the PSYC register and have a current Cat 6 or higher Equipment Audit certification. An exemption is provided allowing Cat 7 for yachts with no accommodation.
- 3.2. Eligible boats may enter by logging on with the Race Officer prior to the Warning Signal on VHF CH 77 including.
- 3.3. Competing yachts and crews are required to comply with the PSYC COVID Risk Management Plan.
- 3.4. Visiting yachts – see the Entries clause of the Sailing Instructions.
- 3.5. Refer to PSYC Sailing Instructions for Special Yacht Provisions.
- 3.6. Other boats are welcome to follow the racing fleet but are not part of the racing fleet. See Starting

**4. FEES**

- 4.1. Racing Membership of the PSYC is required for all or part of the season.

## **5. RACE SCHEDULE AND START TIMES**

- 5.1.** Racing is scheduled as per the published PSYC Sailing Program or as published on the PSYC Notice Board and PSYC Website.
- 5.2.** Racing will be conducted at a nominal start time of 1300hrs.

## **6. RACE COURSE**

- 6.1.** The Start and Finish will be the transit between the two posts on the the PSYC signal mast located in the vicinity of the Soldiers Point boat ramp car park and bound by the Isolated Danger mark and Boondabah Island or as directed by the Race Officer.
- 6.2.** The planned course is Start – WB(P) – MB(P) – SBM(P) – MB – WB – Finish or an alternative as advised by the Race Officer on VHF77 prior to the Warning Signal.
- 6.3.** If the club burgee is not flying from the PSYC signal mast, a yacht shall take its own finish time, and notify the Vice Commodore, Race Officer or a Race Committee member as soon as possible to enable the presentation of provisional results, and before 2130 hours on the day of the race. A finish sheet is provided at the PSYC for this purpose.

## **7. SAILING INSTRUCTIONS**

- 7.1.** The Sailing Instructions are available from the Vice Commodore, PSYC Notice Board or the PSYC website.

## **8. PRIZES AND SCORING**

- 8.1.** Prizes will be awarded at the discretion of the PSYC.
- 8.2.** Allocation of handicaps and system employed to ascertain results will be at the discretion of the Race Committee.

## **9. DISCLAIMER OF LIABILITY**

- 9.1.** All those taking part in PSYC races do so at their own risk and responsibility. The PSYC is not responsible for the seaworthiness of a yacht, the sufficiency or adequacy of its equipment or the competency of its crew.
- 9.2.** The PSYC reserves the right to refuse entry to any yacht at any time.
- 9.3.** Attention is drawn to the Fundamental Rule 4 which states: The responsibility for a boat's decision to participate in a race or to continue *racing* is hers alone.

## **10. INSURANCE**

- 10.1.** All yacht participating in PSYC events, including cruises, are required to have valid and current third-party liability insurance which includes indemnity for the PSYC.
